A. CALL TO ORDER

District Manager Neil Kalin called the June 21, 2018, Regular Board Meeting of the Coronado Community Development District to order at 6:21 p.m. in the Islands at Doral Clubhouse Meeting Room #2 located at 8250 NW 112th Court, Doral, Florida 33178.

B. PROOF OF PUBLICATION

Mr. Kalin presented proof of publication that notice of the Regular Board Meeting had been published in the *Miami Daily Business Review* on September 28, 2017, June 1, 2018, and June 8, 2018, as legally required.

C. ESTABLISH A QUORUM

Mr. Kalin determined that the attendance of Chairperson Erwin Santacruz, Vice Chairperson Gladys Huot, and Supervisors Roman Gomez and Digna Cabral constituted a quorum and it was in order to proceed with the meeting.

Staff in attendance included: District Manager Neil Kalin of Special District Services, Inc.; and District Counsel Alyssa Willson (attended via conference call) of Hopping Green & Sams, P.A.

Also present was Juana Montes, HOA Manager, Castle Group; Reza Pour and George Paz of U.S. Security, Miami, Florida; and Chris Brouwer of Security Watch Group LLC, Doral, Florida.

D. ADDITIONS OR DELETIONS TO THE AGENDA

There were no additions or deletions to the agenda.

E. COMMENTS FROM THE PUBLIC FOR ITEMS NOT ON THE AGENDA

There were no comments from the public for items not on the agenda.

F. APPROVAL OF MINUTES 1. May 17, 2018, Regular Board Meeting

Mr. Kalin presented the minutes of the May 17, 2018, Regular Board Meeting and asked if there were any changes and/or corrections. There being no changes, a **motion** was then made by Ms. Huot, seconded by Ms. Cabral and unanimously passed to approve the minutes of the May 17, 2018, Regular Board Meeting, *as presented*.

<u>Note</u>: At approximately 7:26 p.m., Mr. Kalin recessed the Regular Meeting and simultaneously opened the Public Hearing to receive comments on the Fiscal Year 2018/2019 Budget.

G. PUBLIC HEARING 1. Proof of Publication

Mr. Kalin presented proof of publication that notice of the Public Hearing had been published in the *Miami Daily Business Review* on June 1, 2018, and June 8, 2018, as legally required.

2. Receive Public Comment on the Fiscal Year 2018/2019 Final Budget & Assessments

Mr. Kalin opened the public comment portion of the public hearing to receive comments on the fiscal year 2018/2019 final budget and non-ad valorem special assessments. There being no public in attendance, there were no comments from the public on the fiscal year 2018/2019 budget and assessments. Mr. Kalin then closed the public comment portion of the Public Hearing.

3. Consider Resolution No. 2018-02 – Appropriations Resolution Fiscal Year 2018/2019

Mr. Kalin presented Resolution No. 2018-02, entitled:

RESOLUTION 2018-02

THE ANNUAL APPROPRIATION RESOLUTION OF THE CORONADO COMMUNITY DEVELOPMENT DISTRICT (THE "DISTRICT") RELATING TO THE ANNUAL APPROPRIATIONS AND ADOPTING THE BUDGET FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2018, AND ENDING SEPTEMBER 30, 2019; AUTHORIZING BUDGET AMENDMENTS; AND PROVIDING AN EFFECTIVE DATE.

Mr. Kalin read the title of the resolution into the record and stated that the document provides for setting aside revenues for specific purposes from the Coronado Community Development District (the "District") fiscal year 2018/2019 budget by the levying of special non-ad valorem assessments. Furthermore, Mr. Kalin stated that the Board shall adopt a budget for the ensuing fiscal year and appropriate such sums of money as the Board deems necessary to defray all expenditures of the District for the General Fund (Operations & Maintenance) and Debt Service Fund (Bond Principal & Interest). A discussion ensued after which:

A **motion** was made by Ms. Cabral, seconded by Mr. Santacruz and passed unanimously to approve and adopt Resolution No. 2018-02, *as presented*, setting the sum of \$519,141 to be raised by the levy of assessments for the fiscal year 2018/2019, which sum is deemed

by the Board of Supervisors to be necessary to defray all expenditures of the District during the fiscal year commencing October 1, 2018, and ending September 30, 2019.

4. Consider Resolution No. 2018-03 – Assessment Resolution/Tax Roll Fiscal Year 2018/2019

Mr. Kalin presented Resolution No. 2018-03, entitled:

RESOLUTION 2018-03

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE CORONADO COMMUNITY DEVELOPMENT DISTRICT MAKING A DETERMINATION OF BENEFIT; IMPOSING SPECIAL ASSESSMENTS; PROVIDING FOR THE COLLECTION AND ENFORCEMENT OF SPECIAL ASSESSMENTS, INCLUDING BUT NOT LIMITED TO PENALTIES AND INTEREST THEREON; CERTIFYING AN ASSESSMENT ROLL; PROVIDING FOR AMENDMENTS TO THE ASSESSMENT ROLL; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

Mr. Kalin read the title of the resolution into the record and stated that the document provides for the determination of benefit (benefit allocation per unit exceeds the debt apportionment per unit) and imposing special assessments; for the collection and enforcement of the special assessments; and for certifying an assessment roll. The fiscal year 2018/2019 budget and Assessment Roll were made available at the meeting. The District shall collect the special assessments in the same manner as County taxes in accordance with the Uniform Method (Section 197.3632, Florida Statutes). A discussion ensued after which:

A **motion** was made by Ms. Cabral, seconded by Ms. Huot and passed unanimously to approve and adopt Resolution No. 2018-03, *as presented*, thereby imposing special assessments for the 2018/2019 fiscal year; providing the Uniform Method for the collection and enforcement of special assessments; certifying an assessment roll; and providing for amendments to the assessment roll, as required.

<u>Note:</u> At approximately 7:30 p.m., Mr. Kalin closed the Public Hearing and simultaneously reconvened the Regular Meeting.

H. OLD BUSINESS

1. Staff Report: Update Regarding the 2017 Project

Mr. Kalin advised the Board that the 2017 Project final plans will be completed by the end of next week after which Staff will seek proposals for the work. Ms. Willson advised the

District Manager to be aware of project threshold limits so that the District is in compliance with sealed bid requirements.

2. Staff Report: As Required

There was no Staff Report at this time.

I. NEW BUSINESS

1. Consider Resolution No. 2018-04 – Adopting a Fiscal Year 2018/2019 Meeting Schedule

Mr. Kalin presented Resolution No. 2018-04, entitled:

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE CORONADO COMMUNITY DEVELOPMENT DISTRICT, ESTABLISHING A REGULAR MEETING SCHEDULE FOR FISCAL YEAR 2018/2019 AND SETTING THE TIME AND LOCATION OF SAID DISTRICT MEETINGS; AND PROVIDING AN EFFECTIVE DATE.

3. Consider Resolution No. 2018-06 – Adopting a Revised Statewide Mutual Aid Agreement

Mr. Kalin presented Resolution No. 2018-06, entitled:

RESOLUTION NO. 2018-06

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COROANDO COMMUNITY DEVELOPMENT DISTRICT, STATE OF FLORIDA, APPROVING THE *REVISED* FLORIDA STATEWIDE MUTUAL AID AGREEMENT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

Mr. Kalin provided an explanation for the document. A discussion ensued after which;

A **motion** was made by Ms. Cabral, seconded by Mr. Santacruz and unanimously passed to approve and adopt Resolution No. 2018-06, *as presented*; thereby accepting the revised Mutual Aid Agreement between the District and the State of Florida.

J. ADMINISTRATIVE & OPERATIONAL MATTERS 1. Discussion Regarding Security Services and Vendor Proposal Presentations

Mr. Kalin introduced the two (2) security companies present, U.S. Security (Reza Pour & George Paz) and Security Watch Group LLC (Christopher Brouwer) and informed the Board that the vendors were in attendance to provide an overview of their services and to demonstrate the personality of their individual companies. Both security companies were well versed in security procedures and welcomed the opportunity to serve the District. After the individual presentations the Board requested the District Manager obtain formal
